



### **HOLD HARMLESS AGREEMENT**

Lizardopolis provides a unique program where we bring education and exotic reptiles, amphibians and animals to you! Your child will be able to learn about and have direct contact with live animals that include but are not limited to: African Ball Python, Corn Snake, Leopard Gecko, Russian Tortoise, White's Tree Frog and Giant Madagascar Hissing Cockroach. Every effort will be made to keep your children safe. Our animals are not poisonous, venomous, or sick and have never exhibited aggression towards anyone. However, anything with a mouth and teeth can bite.

**IMPORTANT: PLEASE READ THE FOLLOWING LEGAL DOCUMENT CAREFULLY**

#### **ACKNOWLEDGEMENT, WAIVER AND RELEASE**

I, the undersigned, give my child permission to participate in the event or party where Lizardopolis will present unique and exotic animals. I understand that participation involves my child being both in the vicinity and in direct contact with live animals of various species. I have been informed and I completely understand and acknowledge that, although extreme careful precautions will be used for the safety of all children participating in the Lizardopolis Event, there are possible risks involved for my child as they will be handling animals. I understand that any and all animals may react in an impulsive and unpredictable way as a result of, but not limited to, people, sounds, sudden movements, or other animals which could result in injury to my child. I will not hold anyone from Lizardopolis, or any participant of this event, liable for any accident, including but not limited to injury, illness, property damage, or any other loss sustained by me or my child (or the child I am representing), arising from or due to any cause whatsoever.

By signing below, I am verifying that I am the adult who has legal authorization to speak for the child whose name appears below.

I HEREBY WAIVE AND RELEASE, indemnify, hold harmless and forever discharge Lizaropolis, its owners, its heirs and personal representatives, and all firms, corporations, and persons on their behalf liable, from any and all claims, demands, damages, actions, or causes of action arising from or growing out of any and all personal injuries and/or property damage that my child may incur while participating in any part of the Lizardopolis event.
